This website has been developed by the Nebraska State Historical Society, Nebraska Educational Telecommunications, and the Nebraska Department of Education. It provides a historical timeline for Nebraska, even before statehood. Following are some of the pre-statehood dates of note:

1541 – Coronado/Spanish

1600 - Native Tribes Return to the Plains

1650 – Horses Stolen from Spanish Transform Native Lives

1720 - Villasur Sent to Nebraska

1714 – French Trader Uses Oto Word to Name "Nebraskier"

1803 – Louisiana Purchase

1814 – Fur Trader Manual Lisa Settles Bellevue

1820 - Fort Atkinson Built

1830 - Oregon Trail

1854 – Kansas-Nebraska Act Signed

1855 - First African-American Settler/Free Public Schools

1862 – Homestead Act Signed/Union Pacific Railroad Chartered

Seven eras, each covering 25 years, are featured. There are also six sections titled "Notable Nebraskans." Susan La Flesche Picotte and J. Sterling Morton are among the notables.

There are teacher activities and lesson plans available for each period. The pages also include maps, paintings, political cartoons, and videos. While Nebraska Social Studies Standards are listed, please check to be sure they are the current Standards.

Nebraska State Motto

"Equality Before the Law": Thoughts on the Origin of Nebraska's State Motto
Nebraska legislator Isaac Wiles created the motto, which was adopted on June 15, 1867.

Fourteenth Amendment, U.S. Constitution

One day after adopting the State Motto, the Nebraska Legislature ratified the Fourteenth Amendment, making it the 24th state to do so. It extended "equal protection of the laws" to all people within a state's jurisdiction. https://www.law.cornell.edu/constitution/amendmentxiv

The words of the State Motto appear at the top of the State Seal, which is kept for official use in the office of Nebraska's Secretary of State. Replication of the State Seal in print or other media requires special permission from the Secretary.
